MS-Steel Oy is resolutely committed to the continual improvement of our environmental performance, through constant review, in order to adhere to an efficacious Environmental Management System (EMS). The scope of our EMS encompasses the manufacturing and installation of heavy welded steel constructions at MS-Steel Oy workshop in Hanko and other installation sites. This Environmental Policy has been formulated to meet the requirements of ISO 14001:2015 and is applicable to all areas of our business. The Environmental Policy is based on the following fundamental principles:

- Pollution prevention and environmental protection to prevent any adverse environmental impact in all aspects of our business and operations
- Recycling and reusing materials wherever practical
- Minimising the environmental impact for the life cycle (including disposal) of all equipment and other physical assets under our control
- Compliance with all applicable legislation, regulations and relevant Codes of Practice.

The following MS-Steel operations have been identified as the main sources of potential adverse environmental impact:

- 1) Surface treatment operations, including the use of paints and other chemicals
- 2) Generation of scrap metal
- 3) Energy consumption during manufacturing activities (including reworks)
- 4) Transportation and logistics operations
- 5) Proper recycling and disposal of oil change from trucks
- 6) Control of heating to ensure that it is not running unnecessarily.

## Monitoring our progress - Objectives, Targets and Management

Management reviews progress against the Environmental Policy and objectives annually. We ensure that we adhere to our Policy and address resulting actions identified through it. Our Environmental Management System (EMS) includes measures to control abnormal and emergency situations. We have communicated our current Environmental Policy to our clients, their representatives, subcontractors, suppliers and all persons working for or on behalf of MS-Steel, to promote environmental awareness and to gain support in meeting our environmental objectives. Our employees have been briefed on our Environmental Policy and are fully aware of its requirements.

## Working in partnership

We consult with Local and National Government bodies, enforcing and regulatory authorities, and specialists to seek advice and assistance towards fulfilling our Environmental policy. We comply with regulations, legislations, codes of practice and other requirements associated with MS-Steel and it operations.
